**PURPOSE:** The Muleshoe Area Hospital District Board of Directors will discuss and take possible action regarding a First Amendment to the Tax Abatement Agreement with Lazbuddie Wind Energy LLC dated on or about May 28, 2020, pursuant to Chapter 312 of the Texas Tax Code.

**Property Owner and Applicant for Tax Abatement:** Lazbuddie Wind Energy LLC

**Reinvestment Zone:** Parmer-Lazbuddie Wind Reinvestment Zone

**Property in Reinvestment Zone:** See attached map and legal description provided in Exhibit "A" attached hereto and incorporated herein for all purposes.

**Anticipated Improvements:** The general description of the nature of the improvements included in the agreement is as follows: Lazbuddie Wind Energy LLC anticipates the following improvements: wind turbines, towers, foundations, roadways, buildings, offices, meteorological equipment including anemometer towers and SODAR, computer equipment, furniture, company vehicles, electrical transmission cables and towers, electrical substations; and associated equipment for generating, storing, controlling, and transmitting electricity.


**Summary of Proposed Amendments:** The First Amendment to the Tax Abatement Agreement would extend the Commercial Operations date so that the Owner agrees that the Project shall achieve Commercial Operations on or before December 31, 2025.

**Estimated Cost of the Improvements:** The estimated cost of the improvements being contemplated by Lazbuddie Wind Energy LLC is between \$175,000,000.00 - \$275,000,000.00.

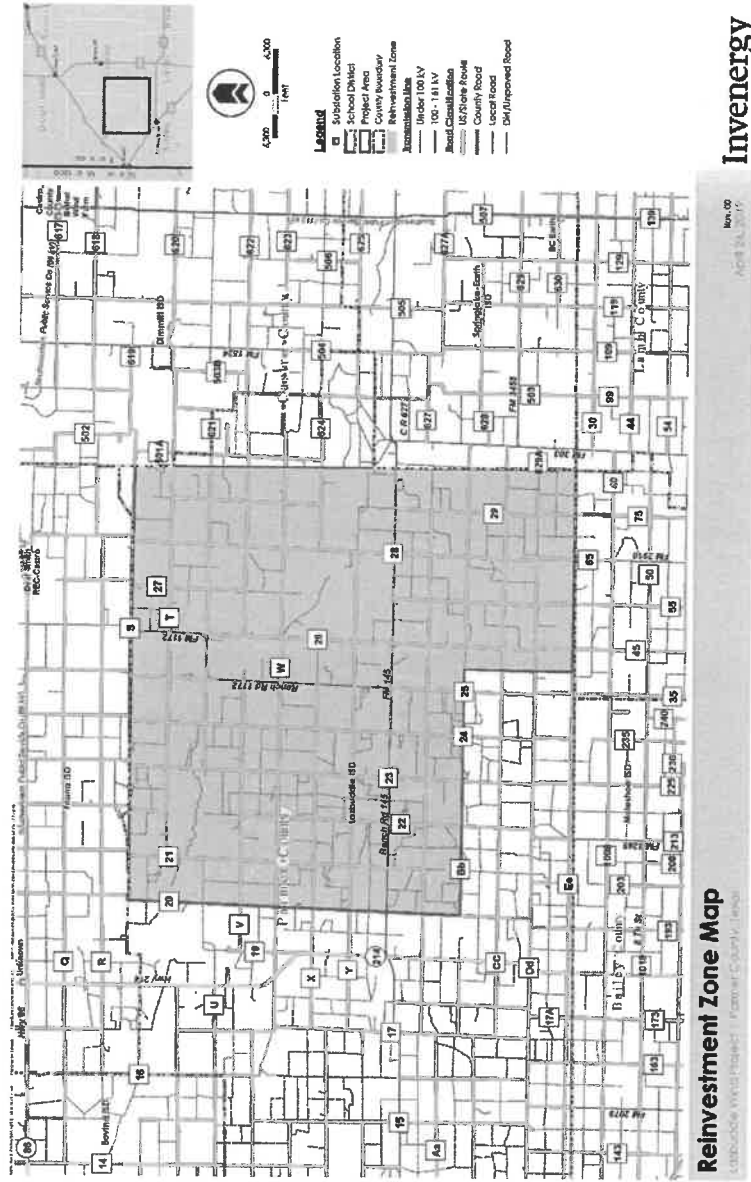
